#### Eligibility:

The candidates should have Bachelors Degree in any discipline & 2 year work experience after graduation (one year in case of Post – Graduates or those with professional qualification).

#### Admission Procedure:

Entrance Test is mandatory, followed by Group Discussion and Personal Interview.

#### Application Procedure:

##### 1. Offline Application:

- Application Form can be obtained from IMT Admission office against a cash payment of Rs. 1750/- (One Thousand Seven Hundred fifty only) or by post sending a request along-with the draft of Rs. Rs. 1750/- (One Thousand Seven Hundred fifty only). Demand draft should be in favour of Institute of Management Technology payable at Ghaziabad / Delhi.
- Apply in the prescribed Application Form attached herewith.
- Filled in and completed Application Form should reach IMT Admissions Office latest by April 30, 2010.
